Li Ka-shing Presented with Lifetime Achievement Award at the DHL/ SCMP Hong Kong Business Awards 2010

[2 December, 2010 – Hong Kong] – Mr Li Ka-shing, Chairman of Cheung Kong (Holdings) Limited and Hutchison Whampoa Limited, was presented the “Lifetime Achievement Award” at the DHL/ SCMP Hong Kong Business Awards 2010 today.

The Hong Kong Business Awards were established by DHL and the South China Morning Post with the aim of publicly acknowledging the vital contributions made by individuals and companies in developing the economy and international stature of Hong Kong and the Pearl River Delta, as well as to encourage the region’s entrepreneurial spirit and recognize excellent standards of corporate management and governance. The Lifetime Achievement Award is given to an individual in recognition of his business and social contribution to Hong Kong over a sustained period of time.

Accepting the Lifetime Achievement Award on behalf of his father at the awards ceremony, Mr Victor Li Tzar-kuoi, Managing Director and Deputy Chairman of Cheung Kong (Holdings) Limited, said: “I am delighted to accept the Lifetime Achievement Award on my father’s behalf. He asked me to convey his gratitude to the organizers and the judging panel for bestowing such an honour upon him.”

“My father has many qualities that inspire me – among them are his vision, acumen, leadership, diligence, dedication and self discipline. I feel very privileged to have the opportunity to work together with him and contribute towards growing the Cheung Kong Group into the multinational conglomerate that it is today with investments and operations spanning 54 countries in the world,” stated Mr Li.

In addition, other members of the Cheung Kong Group have been recognized in the past by the DHL/ SCMP Hong Kong Business Awards. The “International Award” was received by Hutchison Port Holdings in 2002, Cheung Kong Infrastructure Holdings Limited in 2004, and A.S. Watson Group in 2005.
